2-UPDATES FROM THE HRBYCA Board of Directors

Vice President-Gov Affairs and other river related topics

Hudson River Safety and Navigation Committee (HRSNOC): HRSNOC Chairman Ian Corcoran, who also heads up the Hudson River Pilots Association, asked to pass along two requests to all Hudson River boaters:

Those helming large ships and tugs welcome VHF radio boater communications. Capt. Corcorcan encourages recreational boaters to **use channel 13 for bridge to bridge communication** so that boaters can talk directly with the commercial vessels and let them know what your intention is, re: such things as passing/crossing etc.

Consider operating with your boat's **navigation lights on during daytime** in an effort to facilitate visibility and boating safety. Capt. Corcorcan said the effort would greatly help commercial navigators see small craft, and compares the success to vehicle daytime running lights.

HRSNOC also passed a resolution that would require consultation when power cables are being buried in the Hudson River, as well as expressed "...deep concerns that the placement of structures of any type be permitted in a way that will insure the ability of commercial vessels to anchor in the Hudson River in manner that will ensure safety of the vessel, crew, cargo, other vessels and local communities." The short story is the Champlain Hudson Power Express (CHPE) power cable project to lay two, 5-inch cables down the Hudson River may be

buried at a depth at the bottom of the river that HRSNOC feels is too shallow and could be snagged by a ship in an emergency anchoring situation (ex. loss of power).

NYS DEC <u>announced nearly \$900k in grants</u> that will help make our river a great place to boat and fish. The **grant focus is on dam removal projects** in Putnam County and others north of our region. Funding came from the Environmental Protection Fund. There is nationwide movement to eliminate dams to help bring waterways back to their natural state - this effort has been demonstrated to increase fish stocks and healthier creeks/rivers.

Boaters are Helping Slow the Spread of Invasive Species: Adirondack Almanack reports "The boating season may have unofficially ended Labor Day weekend, but New York State's Watercraft Inspection Steward program continues at select locations. To date, this year's boat stewards have inspected more than 330,000 boats, talked with hundreds of thousands of water recreationists, and intercepted more than 18,000 aquatic plant and animal hitchhikers (including one very important finding of the infamous invasive plant hydrilla!)." We've had our own issues here on the Hudson, such as Hydrilla on the Croton River. Keep up the good work with "Clean Drain Dry" folks!

Tom Lake, a Naturalist at the NYS DEC has a <u>Hudson River Watershed Fish Fauna Checklist you can easily download</u> with **226 species listed** - why not post to your clubhouse bulletin board, share in a boat club email? It's also for those boat club trivia nights or use and a fun check off list for kids etc. If you need a good daily dose of what wildlife is doing on the river (and some escape from COVID), I highly recommend signing up for Tom's "Hudson River Almanac" newsletter where he compiles sightings. You can sign up here.

3-Enviornment/Natural History Happenings

In response to an inquiry by one of our members, Tom Lake replied:

For at least a week now, we have assembled a group of a dozen or so biologists investigating reports of dead Atlantic menhaden from Croton Point to the west side of Manhattan to Jersey City to Staten Island out to eastern Long—a c.100 mile-long reach.

Atlantic menhaden are prone to mortality in the midst of quickly changing environmental conditions such as thermal shock and low D.O. The descriptions of fish behavior in each of these instances are similar. However, water temperature and D.O. levels have not recently fluctuated in a meaningful way at any of these locations which leads us to consider something else: disease. In the interim, Region 3 Fisheries collected some of the fish from Croton Point for analysis. Lab results to come might reveal something.

P.S. It should be noted that Atlantic menhaden are somewhat prone to large-scale fish kills. We had a short but significant menhaden fish kill in the Hudson Highlands last May. Fish kills such as this one likely occurred long before we were here to ponder the cause.
